The candidates will have to appear for the Written Test in the venue mentioned in his/her Admit Card. However, the Chairman of Selection committee, Assam reserves the right to change the venue (s) of the test as per convenience and no representation etc. will be entertained in this regard.

The duration of the Written Test will be of 2 hours on the subjects as given below. The test will be of 100 marks with 100 questions and will be completely OMR based. Each question will carry 1 (one) mark. The candidates will have to use black ball pen to answer the OMR based answer sheet.
